On The Air

HAT A YEAR it has been! When I proposed designating 2011 as "The Year of the Club," I expected big things to happen... and they sure did! From my vantage point, I can point out many good examples, from all over our map. These events have been publicized in this journal, and we can all point with pride to the club accomplishments that we have worked so hard to bring about.

Our numbers are up. More hams are attending meetings and participating in activities sponsored by our clubs. Many clubs have found a new lease on life, and new groups are forming. More of our fellow amateurs are getting on the air. And most importantly, we are starting to see new hams among our ranks—including some who let their licenses lapse decades ago.

What is it that has prompted this recent flurry of ham radio activity? Why are hams spending their hard-earned money during this time of economic uncertainty? I have to believe that it is because the local clubs and their activities are once again proving to be worth the effort and expense.

We all owe a debt of gratitude to those among us who steadfastly have put out the word that Amateur Radio is alive and well, and living in our neck of the woods! As Hollywood actors say, "there is no bad publicity," and this year's efforts to inform the public of our existence, purpose and accomplishments have met with resounding success, time after time.

I'm a member of another fellowship that follows a proven set of traditions and principles that guide their efforts and service. Among these suggestions are placing their principles before personalities, gathering membership by attraction rather than promotion, placing the group's common welfare first (instead of catering to individual egos), avoiding public controversy, encouraging each group to operate independently, while at the same time building unity of purpose among these independent groups, and being completely self-supporting declining all outside contributions, which often come with strings attached.

Throughout all of their traditions is a laser-like focus on their primary purpose--and it would be very advantageous for all of our clubs to focus our attentions likewise. The FCC even states in Part 97 that the central purpose of amateur radio clubs should be... *Amateur Radio!*

Several columns ago, I spoke to the need for every club to have a "Mission Statement." I know, "Mission Statement" is your boss' favorite buzzword of the month as he or she attempts to play along with the fads that were marketed at last month's "Management Conference," but hear me out...

All hype aside, a ham radio club <u>clearly</u> <u>benefits</u> from having a Mission Statement that defines the purpose of the club. Such a statement serves to crystallize the central focus of the group, and helps get everyone working together to provide the important services and activities of the club. That statement should place "Supporting Amateur Radio activities" near the top of the list. That is—and should be—the primary purpose of all amateur radio clubs.

The FCC defines the Amateur Radio Service in terms of service to the public. They recognize the Amateur Radio Service's contributions to the advancement of the radio art. The Amateur Radio Service regulations promote self-policing, resulting in a "reservoir of trained operators, technicians and electronics experts." Finally the FCC recognizes our "unique ability to enhance International goodwill."

It seems to me that every club should make these items the club's primary purpose. This

is what Amateur Radio is all about. Sure, it's a "hobby" but isn't it really much more than that?

I can point to numerous examples of how following these principles has lead to a better amateur radio experience for club members, and the public we serve.

Adherence to these principles will make a good club better, and provide direction and guidance to the struggling club. Devoting our clubs' efforts to amateur radio will guide our service to the public and to our amateur radio community,

These ideals have always served to inspire hams to do their best, and when you're on top of your game, it is all the more enjoyable.

As we conclude this "Year of the Club," we can look back with satisfaction at all we have accomplished. At times our efforts may have been met with resistance—and even hostility —but remaining true to these principles allowed us to continue to serve the public and our amateur radio communities.

Our good work needs to continue, and there is a way to ensure this. You may have noticed the word Service appears many times in this column. It is for a good reason... I'd like for us all to **make 2012 the "Year of Service."**

As we refine and focus our amateur radio activities on serving the public and the amateur radio community, we will all benefit!

ARLB023 Delta Division Sees Leadership Change; Midwest, Atlantic Divisions Unchanged

On November 18, ballots were counted in the races for Director in the Atlantic, Delta and Midwest Divisions. This year, there were only three contested races for Director or Vice Director in the five Divisions holding elections. In the Delta Division, Vice Director David Norris, K5UZ, defeated Director Mickey Cox, K5MC, for the top slot in that Division. Bill Edgar, N3LLR, won reelection as the Director in the Atlantic Division. Cliff Ahrens, KOCA, also was re-elected in the Midwest Division. Terms for Directors and Vice Directors begin at noon on January 1, 2012 and run for three years.

The following incumbents ran unopposed and were earlier declared the winner of their elections by the League's Ethics and Elections Committee: Atlantic Division Vice Director Tom Abernethy. W3TOM; Dakota Division Director Greg Widin, KOGW, and Vice Director Kent Olson, KAOLDG: Great Lakes Division Director Jim Weaver, K8JE, and Midwest Division Vice Director Rod Blocksome, KODAS. The rules state

that if a candidate is running unopposed, he or she shall be declared the winner without balloting.

Atlantic Division

Incumbent Atlantic Division Director Bill Edgar, N3LLR, of Bradford, Pennsylvania, faced two challengers for his position: John Mueller, K2BT, of Falconer, New York, and Philip Theis, K3TUF, of Ephrata, Pennsylvania. Edgar was declared the winner, with 1628 votes. Theis came in second with 1368 votes, and Mueller came in third with 755 votes. This will be Edgar's third term as Director. Before becoming Director in 2006, he served two terms as Vice Director.

"It is great to see such an interest on the part of members in this election," said ARRL New England Division Director Tom Frenaye, K1KI. "I would like to thank everyone for running and also thank the ARRL members in the Atlantic, Delta and Midwest Divisions who participated. The big turnout shows the high level of interest our members have in Amateur Radio and that they take the ARRL elections very seriously."

Along with Frenaye, Roanoke Division Director Dennis Bodson, W4PWF and ARRL Chief Financial Officer Barry Shelley, N1VXY, served as election tellers; Frenaye and Bodson are members of the ARRL's Ethics and Elections Committee. Tiffany Williams from the accounting firm of J. H. Cohn LLP, served as the independent observer.

The next scheduled Division elections are next fall for the ARRL Central, Hudson, New England, Northwestern and Roanoke Divisions. In accordance with League's Bylaws, ballots will be counted on November 16, 2012.

ARLB024 FCC Releases New Rules for 60 Meters

On November 18, the FCC released a Report and Order (R&O), defining new rules for the 60 meter (5 MHz) band. These rules are in response to a Petition for Rulemaking (PRM) filed by the ARRL more than five years ago and a June 2010 Notice of Proposed Rulemaking (NPRM). In the R&O, the FCC replaced one of the channels in the band. increased the maximum authorized power amateur stations may transmit in this band and authorized amateur stations to transmit three additional emission designators in the five channels in the 5330.6-5406.4 kHz band (60 meters).

The Amateur Radio Service in the United States has a secondary allocation on 60 meters. Only those amateurs who hold General, Advanced or Amateur Extra class licenses may operate on this band. Amateur stations must not cause harmful interference to -- and must accept interference from -stations authorized by any administration in the fixed service, as well as mobile (except aeronautical mobile) stations authorized by the administrations of other countries.

PLEASE NOTE THAT THESE CHANGES HAVE NOT YET TAKEN EFFECT. These new rules will

take effect 30 days after they are published in the Federal Register. The ARRL will announce on its website when the rules are published. Additional information can currently be found on the web at, http://www.arrl.org/news/fcc-releases-newrules-for-60-meters.

A Portable HF Vertical

ANY YEARS AGO I was stationed at the U.S. Naval Base, Argentia, Newfoundland. The area was so beautiful and the people were so nice that I've begun vacationing there in recent years. Last summer my wife and I stayed at a B & B in Dildo, Newfoundland. This area was discovered and mapped by Captain James Cook in the 1760's. It is located on Trinity Bay and an excellent area to set up a portable vertical antenna

overlooking the Bay.

On previous trips I used a full sized Dodge RAM pickup truck with mobile HF antennas mounted to the tow mount at the rear bumper. I used an Icom 746 with internal tuner making it easy to tune the 40, 30 and 20 meter band. Over this past year I replaced the pickup with a new Jeep and set about reworking the HF antenna setup which led to experimenting with a portable vertical antenna.

There were several designs on the Internet that used the wheel of the vehicle to hold up the antenna and this looked like a good place to start. I built a bracket from wood that would hold the vertical aluminum mast and electrical connections while being small, light and easy for one person to raise. I was a bit worried about having the body of the Jeep so close to the radiator of the antenna but this

didn't prove to be a problem.

There are several vendors in QST magazine that sell aluminum mast of diameters that will telescope together. While these aren't cheap, they made it easy to build a vertical mast that would come apart easily and store in the Jeep. The mast sections are positioned for length and then held using stainless steel hose clamps. After initial tests

the length of each mast section was marked using black electrical tape. An SO-239 UHF type connector was installed at the wooden base where the coax from the rig would connect. This also was the point where the radial wires were fastened.

Setup sequence is to set the wood frame on the ground and then drive the Jeep up onto it. That takes a little practice but I'm getting better at it now. Once the frame is secure it's time to raise the mast. The number and position of the mast sections depends on the band I wish to work.

Once the mast is in place the radial wires are stretched out. Then the coax to the rig is hooked up and a 3 foot ground rod is driven into the ground. That ground rod lowers the S-meter noise level 1-2 units depending on the band and quality of the ground.

An SO-239 chassis type UHF connector is attached to a plastic insulator. The center black wire connects to the aluminum mast tubing while the radials are connected to the flange bolts

I usually set the radio on the back seat and use the open door to shield the operating position from the wind. Then I sit on a camp stool and work CW with the keyer sitting on the seat next to the rig. When I work SSB the open door also helps reduce wind noise in the microphone.

All this went fairly well with a minimum of



The ICOM 746 is powered up and the auto tuner has matched the antenna to the radio. I've placed the CW key on the seat next to the radio in a comfortable spot trouble. Then I decided to use the Jeep's battery to power the radio. Bad choice!

The battery for the Jeep is located under the passenger seat. It's not made to be used for external power so the terminals are coated with... "stuff" (a highly technical term) that makes them unusable. There are terminals out under the hood for jump-starting the vehicle but I didn't want to use them. There is also a built-in 120 volt AC inverter in the Jeep for powering low wattage appliances. I decided to use that to power a small trickle charger. Then I bought an Optima gel- cell battery to power the radio. The Optima is a sealed battery that can work in any position and not spill acid inside the Jeep. I charge the battery using the trickle charger overnight or when driving so it's always charged and ready for use. I also don't need to worry about running the Jeep battery down and not being able to start the car after a long session at the radio. A side benefit of this arrangement is that the radio is DC powered so power

supply RF noise is not a problem.

After testing the setup at the house I took it to the new **N3NIA Ham** radio site on Boot Jack hill south of Ridgway, PA. The spot is clear of trees and is fairly level. I set

up the antenna and the rig which has an internal automatic tuner. The SWR on the the bands was surprisingly good. All was going well, then Lee N3NWL, Joe N3UGB, Mark KB3VTY and Pete WW30 showed up. They all

Invasion of the QR-Codes

OBOTS FROM outer space have taken over the world! Well, maybe not quite. But it's a fact

that "Smartphones" have captured a significant portion of the mobile telephone market.

Research by the Pew Institute released in July 2011 shows that over 35%

of adults in the US own Smartphones defined as cell phones containing a powerful, general-purpose computer, multi-megapixel still (and HD video) cameras, large, high-



That means that statistically, 140 of you, our readers, already own smartphones. Since we're all hams, and therefore more technology-savvy than the average bear, I'd wager it's more like double that number!

These amazing devices offer capabilities that were science fiction a mere 20 years ago. You can take an autofocused, zoomed, 8 megapixel color photo with the built-in camera, and instantly send it to your friends, hundreds or thousands of miles away. You can even take a full 1080p HD video and stream it live on the Internet!

With that much photographic power, your smartphone can easily become an optical-recognition device. That's where barcodes come into the picture... [pun intended!]

By simply downloading and installing an "app" (short for application) that translates barcodes, you can go through the grocery store (or the ham radio store!) and add up your total before hitting the register!

If you're on a diet, you can compare the nutrition information for items in the database. There are even apps that check online to see if the same item sells for less in any other nearby stores.

There are hundreds of different types of barcodes, each better suited to one purpose or another. The UPC barcode on that can of tuna soup is great at presenting numbers to a cash register, but it is incapable of words.

So-called "2D" barcodes answer that need very effectively. 2D means two dimensions height and width. They look like a matrix of black and white square dots, and have the ability to store numbers, letters, addresses, Internet website URLs, phone numbers and even text like our friend at the left. There are dozens of 2D codes, again each with certain advantages for certain uses. The most popular one today is the QR-Code. Named for it's Quick Response by it's originator, Toyota. It allowed vehicle parts end even whole vehicles—to be tracked through the production line from start to finish.

To use a QR-Code, all you have to do is launch your smartphone's barcode application, and point its camera lens at the code. You will see the results in an instant. If it's a plain-text message or a phone number, you have received it 100% correctly, due to the automatic error correction built in. Depending on the creator of the code, it can be missing as much as 30% of the dots and still decode with 100% accuracy!

But the magic truly begins with Internet addresses. Instead of having to laboriously type in complex URLs with upper and lowercase letters, and numbers and symbols on your smartphone's tiny keyboard, the app captures what's in the QR-code, and opens your web browser to that page, just like in the movies and TV!

When business associates display a QR-Code with their "V-Card" contact information on their phone or on a projection device, everyone present can scan it and automatically add the contact to their phone's address book!

If hams put their callsigns into a QR
 code on their QSL cards or name
 badges, a quick scan could show you who you're talking to, and even bring up their QRZ page!

It's a safe bet that you'll be seeing these things a whole lot more! They may not be

robots from outer space, but they certainly are an advanced technology!

proprietary app called "Skype Mobile ™" which uses up the minutes of your phone plan. It does not support video chat, either! Check your phone's EULA to see if you are allowed to use this full version. If you are allowed, install this app instead, which uses WiFi if available and 3G/4G

/EVDO. You can make video calls. use text messages, and use all the Skype features without running up huge overtime bills.
