But the time has come to open a new chapter for ARRL. At a recent special Board of Directors' meeting held on August 22 for the purpose of selecting a new Chief Executive Officer, the Board elected Dr. Howard Michel, PhD, WB2ITX, to become the new CEO of ARRL and lead the HQ staff. As have all the past CEOs, Howard will report directly to the ARRL Board of Directors and be responsible for carrying out the policies and objectives established by that group. I will be around a while longer to help create a smooth transition, but will phase out my involvement over time.

Obviously, the current environment, which I summarized in my first-ever column in the April 2018 issue of *QST*, still exists. That being the case, Howard is taking the helm at a time of significant challenges for Amateur Radio and ARRL. Your support for him and the organization will help determine how successful we are in meeting those challenges, and will allow us to continue to pursue ARRL's mission of "...advancing the art, science, and enjoyment of Amateur Radio...". While I'm sure we may disagree to some extent on how to accomplish this mission, I also believe there is little disagreement, if any, on the objective itself. In my opinion, it is critical for ARRL to continue to promote Amateur Radio and provide support, services, and information for all classes and abilities of ham radio operators. It is the only way that we can survive.

And before I sign off, I would like to remind those of you who are full members in the Central, Hudson, New England, Northwestern, and Roanoke Divisions that you will be receiving a ballot in the Division elections, if you haven't already. I personally believe it is important for you to exercise the opportunity presented to you as a member and vote on who you want to be your Division representative on the ARRL Board of Directors. I urge you to do so.

Thank you again for allowing me to serve ARRL for all these years.
